The Houston City Council met in regular session at 6:30 P.M. on Tuesday, November 12th, 2024, at Houston City Hall Council Chambers, 601 S. Guests:

Isabella Tibbets with TREKK Design Group presented results from the 2024 sewer inspections that took place throughout the city. The results were composed from evaluations in flow meter monitoring and smoke testing that were completed in spring and fall of this year. Individual reports were provided for both, in addition to overall recommendations for improvement. The total cost associated with improvements total more than a million dollars, but grants and funding options are available, depending on what improvements the city decides to pursue.

Morgan Patterson with the Chamber of Commerce discussed the upcoming 2024 Christmas Parade. The parade will run a designated route- starting and ending at the Houston High School parking lot but including Pine St, 1st St, Grand Ave and Walnut St. Mr. Patterson reports they will request all vendors/ food trucks contact City Hall for a permit. Council Members suggesting the vendors be setup at Lonestar Plaza. The parade is scheduled for December 14th, 2024 at 6:00 P.M. The motion was made by Alderman Ceplina and seconded by Alderwoman Gettys for the Police Dept / Public Grounds Dept setup barricades and shut down the affected streets for the Christmas Parade on December 14th, 2024.
