Tammy Burns presented to members a proposal for a city-wide trap and release program pertaining to feral cats. Alderman Stottlemyre to arrange a Police and Fire Committee meeting to further discuss, in hopes of finding a resolution.

Economic Developer, Kevin Buck, presented a bid for \$27,000 for a digital billboard.

Pump House at the Golf Course: Parks and Recreation Supervisor, Robbie Mortensen, brought up discussion regarding the pump house at the golf course. He reported the pump is now inoperable and he proposed a plan to build a new pump house approximately 100 ft from the current location. He presented members of the council with a bid from Mahan Drilling and Pump Service of Houston for \$12,000 for a new pump and motor. He sought two other bids, but information was not received. Mortensen reported that most of the work would be completed by city crews for the new pump house.

The motion was made by Alderman Ceplina and seconded by Alderman Stottlemyre to approve the purchase of a new pump, motor and construction of a new pump house building using American Rescue Plan Act (ARPA) funds, not to exceed \$35,000. Motion carried with six yes votes.

Utility Committee Update: Alderman Kelley updated that the Utility Committee held a meeting Monday, August 12<sup>th</sup>, 2024, regarding fiber installations and rates. City Attorney, Sean Smith, is working on several potential updates.

Police and Fire Committee Update: Alderman Stottlemyer updated that the Police and Fire Committee held a meeting Wednesday, August 14, 2024, regarding ordinances. Bills 114 and 115 regarding nuisances, are still under review. City Attorney Smith is continuing to work with Police Chief, Brad Evans, on details- Police and Fire Committee planning to hold another meeting for further discussion.

Miscellaneous:

City Administrator Wells presented a bid to council members for rubber nuggets (a budgeted item) to use around the playground equipment at city parks.

The motion was made by Alderman Stottlemyre and seconded by Alderman Ceplina to purchase rubber nuggets for \$12,993.53 for playground surfacing. Motion carried with six yes votes.

The motion was made by Alderman Kelley and seconded by Alderwoman Walker to close the regular session of the meeting at 7:47 P.M. and move to executive closed session in pursuant to Section 610.021 subsection (1) contracts.
