Guests:

Karen Duhart presented to members a plan for a city-wide trap and release program pertaining to cats only. She believes there is a better alternative than fining residents who are attempting to help strays. Administrator Wells to gather further information about potential grants to assist with funding.

Economic Developer Kevin Buck presented information regarding Placer AI- an analytic data collection service. \$7,000 annual subscription.

Parks and Recreation Supervisor Robbie Mortensen brought up discussion regarding food/drink (alcohol potential) at the golf course. Currently, there is no food or drink available to purchase. Discussion took place regarding the use of the upstairs for serving purposes. Adam Vandiver spoke about a potential contract with the City of Houston with he and his wife, Willa, to handle those sales. Further discussion to take place with Wells and be presented to the council. Robbie Mortensen also spoke on the quadplex. Discussion occurred about potentially scheduling a meeting to discuss the prelim budget and plan with the current contract provider or potentially using a bond vote and completing only two fields initially.

Public Comments:

Carmen Roeder spoke about her concern for sewer rates. She would like to see a fixed rate cost vs related service charge. Mayor Narancich requested Administrator Wells gather further information from neighboring towns regarding sewer rates and billing.

Bill 114 to become Ordinance 2024-114 (11-64 Definitions) was placed for a 2nd reading but Narancich requested further review before a 2nd reading. Discussion was held about splitting the ordinance into two policies: commercial and residential.

Bill 115 to become Ordinance 2024-115 (Nuisance declared) was placed for a 2nd reading but will also go back under further review by the Police and Fire Committee.

Bill 116 to become Ordinance 2024-116 (tax levy). The motion was made by Alderman Romines and seconded by Alderwoman Walker to place Bill 116 on first reading by title only. Motion carried with five yes votes.
