Guests:

Lisa Linn- The Brushy Creek Management Proposal was presented to the council discussing vegetation management at The Brushy Creek Riparian Buffer. The bufferlocated at the intersection of Walnut Street and Oak Hill Drive- was established in 2008. However, many invasive species of vegetation have established within the wildflower opening and the wooded corridor. With proper management, the area could contribute to improved water quality, reduction in sedimentation, proper filtration of pollutants, slow the flow of water runoff, limit impacts of severe flooding and provide a habitat for wildlife. In partnership with the Natural Resources Conservation Service (NRCS), Missouri Department of Conservation (MDC), Quail Forever and with monthly volunteer events, the city could work to restore and maintain the natural area with limited costs. The city would invest approximately \$3,000 in addition to 40-man hours within the first year for initial vegetation management. Afterwards, maintenance cost would decrease to approximately \$300 with 10-20 man hours needed, annually. Emily Lear, MDC land conservationist, explained cost share opportunities available for reimbursement (up to 50%).
