Rick Bond and Roxanna Guevara introduced their new business, The Beauty Bar to the council. Public Comments:

Morgan Patterson, Chamber President provided comments regarding the possible electric rate increase. Patterson stated that business owners and the elderly would suffer the most and ask the council not to raise rates.

Kevin Stilley, Chamber Board Member provided comments regarding the possible electric rate increase. Stilley stated he believes the electric component of the city budget is profitable and asked if the supplier of the City's electric has raised rates. Stilley believes that in the future the rates will increase and the City will be forced to raise rates.

Joe Honeycutt, City Treasurer provided comments regarding the possible electric rate increase. Honeycutt believes the City should increase electric rates in small increments every year to avoid substantial rate increases. He stated there was no electric rate increase last year and that the City's reserves are for disasters.

Three other individuals filled out cards to speak during public comments but either declined or had already left the meeting when their name was called.
