City Administrator Wells reported that he received a structural engineer cost estimate from Benton and Associates with a range of \$2,000 to \$5,000. After discussion about the dangerous structural buildings on Grand Ave, the council directed City Administrator Wells to put a public notice in the Houston Herald and to have a formal letter addressed to the building owner prepared and presented at the next regular council meeting on May 5, 2025. According to county records, the owner of the buildings is Floyd Mayberry of The Living Way Ministry of Bible Health Inc. The council ask that barricades be put up soon in the ally way along the building and in front of the building on the sidewalk to avoid someone getting hurt.
