Guests:

Janice Weddle with University of Missouri Extension presented a plaque to City of Houston for Missouri's Most Neighborly City 2024. City of Houston received first place for small city population under 5,000. City Administrator Wells was presented the plaque.

Kelly Beets, MIRMA senior loss control consultant announced the City of Houston was awarded a Risk Management Grant for the items applied for through the program. The items applied for were police department car camera, public works emergency flood lights and gas detectors. The award was presented to City Administrator Wells.

Jeff Gettys, TCMH Director Office of Projects & Foundation gave an update on the CID budget and the cost certifications. The cost certifications were \$2,000 counsel fees, \$1,883 legal fees, and \$170,620 equipment fees. Alderman Romines stated the city has failed to collect a 1.5% from the monthly tax for administrative fees.

Brad Rees reported the light is up at Acorn Street and the residents appreciate it. Rees responded to Doug Gaston's comments from the last meeting concerning a neighborhood dispute regarding a barrier between his residential property and Gaston's new commercial gym. Rees reported that the daily harassing calls to police was due to loud music and that it has gotten better. He just wants the laws applied equally.

Doug Gaston asked the council if they had any questions. Doug reported that trees have been planted as a barrier.

Parks & Recreation Director Robbie Mortensen reported one RFQ for the quadplex has been received from Midstate Pipeline. Director Mortensen stated Midstate Pipeline has done a good job on the new quadplex and recreation center in Belle, MO. A survey will have to be completed before knowing excavation costs. Mayor Narancich asked City Administrator Wells and Parks & Recreation Director Mortensen to invite Midstate Pipeline to the next scheduled council meeting on December 2nd, 2024. Alderman Stottlemyre requested an update on the water pump at golf course. Mortensen stated the parts have not come in and it will take two to three weeks for testing after the pump is installed. The pump should be up and running by Spring. Mortensen also gave an update on the sidewalk project at Bridges Park.

The remaining ARPA funds need to be allocated for 2025. APRA funds will be discussed in the budget meeting November 25th, 2024.

Mayor Narancich stated the Park Board would like to appoint Jake Brookshire and P.J. Murray to the Park Board. The motion was made by Alderman Ceplina and seconded by Alderwomen Walker to appoint Brookshire and Murray to the Park Board. Motion carried with five yes votes.
